Each undersigned Trustee certifies that the Trust is currently in existence, has not been revoked, modified or amended in any manner that would cause the certifications herein to be incorrect, and agrees to inform BWIS immediately in writing of any amendment to the Trust, any change in the composition of the Trustees, or any other event that could alter the continued validity of this Trust Certification.

This indemnification is made by each Trustee in his/her capacity as a Trustee and in his/her individual capacity. This certification is in addition to (and in no way limits or restricts) any rights that BWIS may have under any other agreement or agreements between the undersigned Trustees and BWIS.
